# D1b. ACCEL Liability Claims Auditor

The current Claims Auditor Contract with Farley Consulting Services that was entered into in 2008 has been amended each year but was missing some pertinent clauses. For example, the current Farley Consulting Services Contract had no termination clause. The Program Administrators drafted a new contract with changes to the 2008 contract that included changes appropriate to any agreement that ACCEL would have with a service provider and important clauses required for CAJPA Accreditation.

The Committee discussed the draft contract that was prepared and signed by Tim Farley. The Committee's discussion centered around the quality of Mr. Farley's audits and the value of the annual auditing process. The Committee also noted that the draft contract's scope of work (approved by Mr. Farley) appears to be inconsistent with Mr. Farley's actual scope of work (i.e., the contract commits to a larger audit scope than Mr. Farley actually carries out). Alliant staff agreed to follow up on this issue.

A motion was made to direct the Program Administrators to complete the following and report back at the next Claims Committee Meeting:

- 1. Verify with the first excess carrier if there is a requirement of an annual audit.
- 2. Verify the CAJPA Accreditation Standard if an annual audit is required.
- 3. Inquire with Byrne Conley his legal opinion on whether accepting Tim Farley's December 2016 two year proposal constitutes as a contract.
- 4. Verify with other JPAs who their Claims Auditors are.
