## C. REPORTS

#### C1. UNDERWRITING COMMITTEE'S REPORT

## C1a. Primary and Non-Contributory

The Committee discussed the potential need for a Primary and Non-Contributory endorsement and whether or not ACCEL would want to accommodate. After much discussion, direction was given to the Program Administrators to draft two documents. The first will be a guide for internal City staff that addresses frequently asked questions about coverage aspects of the Memorandum of Coverage (MOC). The second will be an external memo explaining ACCEL's coverage position.

ACCEL's legal counsel is to review the drafts and provide input, and then this is to be revisited at an Underwriting Committee Meeting prior to the June 2025 Board Meeting.

### C1b. Proposed Changes to ACCEL's Underwriting Policy & Procedure

The Committee reviewed the proposed changes to the Underwriting Standards Policy and Procedure (P&P) and weighed the pros and cons of accepting or rejecting the language. These proposed changes add clarity to ACCEL's practices in the Underwriting Standards P&P, which came at the recommendation of the CAJPA Accreditation Committee for the purpose of maintaining CAJPA Accreditation with Excellence.

A motion was made to make a recommendation to the Board to reject the proposed changes to the policy and for the Program Administrators and a few Board Members, if needed, to go back to the CAJPA Accreditor.
