C. REPORTS

C1. Claims Committee

C1a. Claims Reimbursement Requests – Defense Fees

Marcus Beverly reported that ACCEL recently reviewed several cases in which the attorney's working on behalf of ACCEL have charged high hourly rates, sometimes exceeding \$500 per hour. Members have requested an update to the section on Claims Reimbursement Requests in ACCEL's Claims Reporting and Handling Policy and Procedure to address reimbursement of defense fees, including the maximum hourly rates for certain types of litigation. The need for more detailed criteria, and a process for reimbursement of defense bills, has become more acute in recent years due to a number of factors, including: (1) the increased cost of litigation has pushed some defense bills over the Member's SIR, (2) increased settlement costs have exceeded ACCEL's SIR and brought new excess insurance scrutiny on reimbursement requests, and (3) the growing disparity in fees charged by some firms as compared to others.

Included in the agenda packet was a redline version of the Claims Reporting and Handling Policy and Procedure with proposed changes.

The Claims Committee discussed this item and did not reach a recommendation for the Board.

Direction was given to the Program Administrators to create a handout for the January 21 and 22, 2021 Board Meeting about this agenda item, proposing an attorney panel, and allowing a Member to request an exception with the set attorney fees. The Committee will request feedback from the Board.
