C1. ACCEL Program Administration Contract

Conor Boughey reported that the Executive Committee met on February 3, 2021 to discuss the ACCEL Program Administration Contract and the Program Administrators were not in attendance. During that meeting, the Committee delegated authority to Jena Covey to report back to the Program Administrators.

Program Administrators goal of providing thoughtful advice to the Board, and the term of the contract is four-years, starting July 1, 2021 and provides two one-year options to extend.

A motion was made to recommend to the Board at the March 2021 Board Meeting to approve a five-year contract of a flat fee for one year (FY 21/22) and then increase at 2.5% annually for the following four periods (FY 22/23, FY 23/24, FY 24/25, and FY 25/26) with two one-year options to extend. Also, to take Mike Simmons off under Key Personnel, due to his retirement. Direction was given to the Program Administrators to include a redlined and clean version of the contract in the March 2021 Board Meeting Agenda Packet.
