B1a. Excess Liability Renewal Update

At the June 18 and 19, 2020 Board Meeting, the Board took action to bind the Excess Liability Program up to the \$10,000,000 excess \$30,000,000 layer.

Subsequent to that meeting, the Program Administrators obtained quotes excess of \$40,000,000 up to \$55,000,000 which were outlined as Option A and Option B in the handout that was distributed to the Board for today's meeting.

A motion was made to bind Option A as presented in the handout. Option A includes the \$5,000,000 excess \$40,000,000 layer with Gemini, \$5,000,000 excess \$45,000,000 with Great American E&S, and \$5,000,000 excess \$50,000,000 with Hallmark.

Conor and Daniel explained that ACCEL historically has purchased TRIA coverage up to the \$50,000,000 layer. TRIA coverage was purchased from each carrier in its perspective layer.

For the July 1, 2020 renewal, the Program Administrators obtained a Standalone Terrorism Policy quote from Beazley with a \$50,000,000 limit and \$25,000 deductible for \$96,373.

A motion was made to purchase the Standalone Terrorism Policy with Beazley and not purchase TRIA coverage from the carriers in the Excess Liability Program layers.
