C. REPORTS

C1. Claims Committee

C1a. Legal Expenses Related to Santa Monica's Coverage Matters

Conor Boughey reminded the Claims Committee that Howard Wollitz was hired by ACCEL to assist with an old Santa Monica claim dating back to the 1980s.

Byrne Conley, ACCEL's Legal Counsel confirmed that ACCEL's work with Howard to provide a coverage opinion, reservation of rights, and other legal assistance are legal expenses and not allocated loss adjustment expenses (ALAE).

The Committee discussed and agreed that these expenses from Howard Wollitz are legal expenses and fall under the Legal Counsel Budget in the Admin Budget.

Direction was given to the Program Administrators to propose a \$15,000 Legal Counsel Budget in the Admin Budget at the June 2021 Board Meeting.

C1a. Brower Law Group Fee Tracking

Conor Boughey noted that included in the agenda packet was a tracking report of what ACCEL has paid the Brower Law Group to date for a City of Anaheim claim.

No reportable action took place.

C1c. Claims Reporting and Handling Policy and Procedure – Proposed Changes

Conor Boughey reported that the Board gave direction to the Claims Committee to review the last two paragraphs at the end of page 4 of 13 of the Claims Reporting and Handling Policy and Procedure (P&P) regarding attorney fees.

To ensure that the P&P contains language that is accurate about reporting to the excess carriers, ACCEL's Legal Counsel, Byrne Conley reviewed and recommend expanding some of the reporting requirements for Member Agencies on page 3 of 13 of the P&P as redlined in the agenda packet.
