### **D1bii. Claims Auditing Process**

Michael Simmons reported that during the July 18, 2017 Meeting, the Committee discussed a variety of options surrounding the claims auditing process and recommendations for improvement. Topics of discussion included the value of the claims audits, alternative methods of conducting the claims audit, and need or advantage of an annual audit.

In order to develop a more thorough plan of action, the Claims Committee gave direction to the Program Administrators to schedule another Claims Committee Teleconference Meeting which will be held on September 21, 2017 to discuss the frequency, methodology, scope of work for claims auditing so the Committee can present an Action Plan to the Board at their upcoming October 2017 Board Meeting in Modesto. (It was generally agreed that annual claims audits should be continued, but significant consideration to obtaining greater value needs to be addressed).

## D1c. Burbank Claims Expense Reconciliation - Rodriguez, et al.

Michael Simmons provided an update that the City of Burbank still has an issue that needs to be resolved in regards to reimbursement of attorney's fees and loss payments for the Rodriguez, et al. claim.

The City of Burbank is proposing to apply a portion of the fees and payments to another claim, Guillen-Gomez to satisfy the City's SIR versus going through David Garthe to provide an analysis of dividing up attorney's fees.

Ken Maiolini, ACCEL's Claims Administrator is currently working on going through all the files that was sent to him by the City of Burbank.

## D1d. Bakersfield's Flat Fee

Michael Simmons reported that the letter attached in the Agenda Packet is the City of Bakersfield's response to ACCEL proposing what is considered fair at applying the defense costs, because the City's current flat fee arrangement does not meet the necessary requirements to satisfy Defense Costs under ACCEL's Memorandum of Coverage.

The Committee discussed various possible resolutions.

A motion was made to accept the letter from the City of Bakersfield. The City of Bakersfield will give ACCEL estimate updates once a claim is filed. This Item will be brought back at the October 2017 Board Meeting.
