
B1. Approval of Minutes for the September 25, 2024 Underwriting Committee Meeting

C1. UNDERWRITING COMMITTEE'S REPORT

C1a. New ACCEL Exposure Questionnaire: City of Palo Alto – Broadband/Internet

The City of Palo Alto submitted a New Exposure Questionnaire regarding Broadband/Internet for the ACCEL Underwriting Committee to review.

The Committee reviewed the questionnaire and discussed. Mark Howard brought up a noted distinction that there were two significant exposures on the questionnaire. The first is failure to supply the utility and the second is the operational exposure of the utility, including installation and ongoing maintenance. The Committee concluded that the current language of ACCEL's Memorandum of Coverage (MOC) matches the intent, that the operational exposures of these utilities be covered but the failure to supply exposure be excluded.

A motion was made to inform the City of Palo Alto there is a failure to supply exclusion and the operational risks are covered subject to other policy language exclusion, and to provide an informational item to the Board.


C1biii. Applicant Fee Structure

The Applicant Fee Structure P&P is reviewed every five years.
